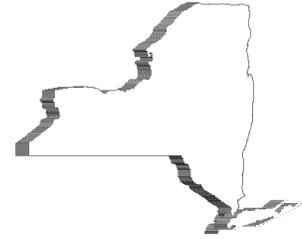

3. Page 020710-2, Subparagraph 1.02 B.3.b.: Delete the following sentence: “(Cost of shoring is provided in unit price item No. 020710.09).” Add sentence: “Cost of shoring shall be included in this unit price. “
4. Page 020710-2, Subparagraph 1.02 B.4.b.: Delete the following sentence: “(Dust protection enclosures and local barriers are included in other unit prices).” Add sentence: “See Section 015000 for dust protection and barrier requirements, to be included in this unit price. “
5. Page 020710-3, Subparagraph 1.02 B.5.b.: Delete the following sentence: “(Dust protection enclosures and local barriers are included in other unit prices).” Add sentence: “See Section 015000 for dust protection and barrier requirements, to be included in this unit price. “
6. Page 020710-2, Subparagraph 1.02 B.6.d.: Delete the following sentence: “(Dust protection enclosures and local barriers are included in other unit prices).” Add sentence: “See Section 015000 for dust protection and barrier requirements, to be included in this unit price.”
