SPECIFICATIONS

- 1. Page 011000-1, Paragraph 1.03 A.: Change "210 days" to read "300 days".
- 2. Page 011000-1, Subparagraph 1.03 A.4.: Change "210 days" to read "300 days".
- 3. Page 012100-1, ARTICLE 1.04 ALLOWANCE FOR NYSEG TO DISCONNECT ELECTRIC SUPPLY: Delete this Article in its entirety, and replace with the following:

"1.03 ALLOWANCE FOR MODIFICATIONS TO EXISTING DIRECT DIGITAL BUILDING CONTROL SYSTEM

- A. HVAC Work Contract: Include in the contract sum the amount of \$99,304 to cover the cost of providing modifications to direct digital building control system as specified in Section 230924 and as shown on the Drawings.
 - 1. The cost of providing the Work of this allowance will be paid in the amount specified. It is a fixed price allowance. Progress payments will be determined, by the Director, by evaluating the work completed.
 - 2. Include overhead and profit for administering this allowance separately in the contract sum, not in the allowance.
 - 3. Cause the products and services covered by this allowance to be furnished by Honeywell Inc. and for such amount as designated.
 - 4. The amount of the allowance includes furnishing the products and services in accordance with the requirements of referenced Specification Section. Labor for installation of the products covered by the referenced Specification Section shall be included in the contract sum (not in the allowance).

- 5 The amount of the allowance includes delivery to the Site and applicable taxes
- 6. Include unloading and on-site handling costs, storage and protection costs, installation costs, and other expenses separately in the contract sum, not in the allowance.
- 7. Purchase and Delivery:
 - a. Execute purchase agreement with designated supplier.
 - b. Arrange for Samples, Shop Drawings, and Product Data as required.
 - c. Make arrangements for delivery.
 - d. Upon delivery, promptly inspect products for damage or defects. Submit claims for transportation damage."
