Important Notice – Administrative Services Award #23057 Expires October 24, 2022:

The OGS Centralized Contract for Administrative Services, Award #23057, expires October 24, 2022. Although it is OGS' intention to have a new Award in place on or before October 25, 2022, it is recommended that Authorized Users use due diligence in planning for their temporary services needs prior to Contract expiration. Purchase Orders must be issued on or before October 24, 2022 (against the current Contract); Purchase Orders (and PCard transactions) may be issued for up to a two-year period (24 months). OGS strongly recommends that Authorized User's issue their Purchase Orders well in advance of the Contract expiration date.

NOTE: OGS is currently reviewing Bids for two replacement Awards for Administrative Services (#23246-Administrative Services - Temporary Personnel, and #23253-Temporary Personnel Services - Language Services), each intended to be issued on or before October 25, 2022. Section 3.3:
