Second Amendment Contract PB160AA

Group 73600 – Award 22772 Project Based Information Technology Consulting Services (Statewide)

THIS SECOND AMENDMENT, (the "Second Amendment") is made between the People of the State of New York, acting by and through the Commissioner of the Office of General Services (hereinafter "State" or "OGS") whose principal place of business is the 36th Floor, Corning Tower, The Governor Nelson A. Rockefeller Empire State Plaza, Albany, New York 12242, pursuant to authority granted under New York State Finance Law §163, and Maureen Data Systems, Inc. d/b/a MDS (hereinafter "Contractor"), with its principal place of business at 307 West 38th Street, Suite 1801, New York, NY 10018. The foregoing are collectively referred to as the "Parties".

WITNESSETH:

WHEREAS, OGS and Contractor are Parties to Contract number PB160AA through which Contractor is authorized to provide for the acquisition of Project Based Information Technology Consulting Services to Authorized Users; and

WHEREAS, The Contract was amended by a First Amendment, dated January 22, 2019; and

WHEREAS, Contractor has subsequently been awarded the following additional Lot: Lot 2 – Project Based Information Technology Consulting Service for projects up to \$7,500,000

NOW THEREFORE, in consideration of the mutual covenants herein contained, the Parties do hereby agree as follows:

SECTION 1: Addition of Lot 2

Appendix G – Contractor Information is hereby deleted in its entirety and replaced with the Appendix G – Contract Information, dated February , 2023, incorporated by reference herein as if fully set forth. All references to Appendix G shall be deemed to reference the Appendix G – Contract Information dated February , 2023.

SECTION 2: Severability

In the event that any one or more of the provisions of this Second Amendment shall for any reason be declared unenforceable under the laws or regulations in force, such provision will not have any effect on the validity of the remainder of this Second Amendment, which shall then be construed as if such unenforceable provision had never been written or was never contained in this Agreement.

SECTION 3: Entire Agreement

The Contract, as amended, constitutes the entire agreement of the Parties with respect to the subject matter thereof, and any further amendment must also be in writing executed by authorized representatives of the Parties.

SECTION 4: All Other Terms and Conditions of the Contract

Except as herein modified, all other terms and conditions of Contract PB160AA shall remain in full force and effect.
