To All State Agencies and others authorized to use State Contracts:

The Office of General Services (OGS) issued Update #23116p73 on May 31, 2024 to notify Authorized Users that Microsoft Reseller Contract PS68202 and its associated underlying Custom Microsoft Business Agreement (CMBA) Contract PS67984 are set to expire on July 31, 2024 and will not be extended. This notification provides additional information and guidance regarding required actions prior to contract expiration and transitioning to the new contract vehicle.

Required Actions by All Authorized Users Before Expiration of Current Contract:

Microsoft Reseller (Statewide) contract PS68202 was originally awarded on August 1, 2018 with a term of five years and was extended for one additional year to expire July 31, 2024. According to the terms of the contract, existing Enrollments and orders placed prior to expiration of the contract will survive expiration of the contract, however the following limitations will apply after the contract expires:

- new Enrollments, new annual orders, and/or new purchases will not be permitted
- SFS users will not be able to issue new purchase orders (for new or existing items on an Enrollment)
- the contract price list will not be updated to include new items, which may include critical patches

To ensure licensing needs and payment obligations will continue to be met following expiration of the contract, orders must be placed and purchase orders must be established for all current or anticipated orders prior to the expiration of the contract.

Example:

- *Authorized User has an existing Microsoft Enterprise Agreement (MS EA) using Microsoft Reseller Contract PS68202 that was for 3 years and one month and expires in December 2024.*
- *AU was planning on issuing a PO for the final month of the MS EA (12/1/24-12/30/24) in November of 2024 but sees that the contract it is based on expires 7/31/24.*
- *The AU also has Azure consumption-based services that they are billed for on a monthly basis.*

To ensure licensing needs and payment obligations will continue to be met, AU will need to issue the POs for the final month of the MS EA and the Azure consumption-based services by deadline of 7/31/24 to continue to effectively use their existing MS EA through its expiration in December 2024.

Note that any new purchasing needs that arise after 7/31/24 would not be able to be fulfilled until the AU established a new EA or migrated their existing EA to the Microsoft Manufacturer Contract PM69723.

Transitioning to the New Contract:

Authorized Users will be required to establish new enrollments or migrate existing enrollments to the Microsoft Umbrella Manufacturer Contract PM69723 (Lot 1 – Software and Lot 3 – Cloud Information) to purchase the Microsoft software and online services currently found on the Microsoft Reseller contract.

Establish New Enrollments under the New Contract:

New enrollments will be subject to the terms and pricing of the Microsoft Umbrella Manufacturer Contract PM69723. To maintain a similar purchasing experience to what Authorized Users currently have when ordering Microsoft software and online products, OGS developed a competitively established transactional agreement, RFQ 24-02 (Microsoft Aggregate Agreement 24-02) in the interest and on behalf of all Authorized Users. OGS anticipates this agreement will be available for use prior to 7/31/24; it will be posted to the OGS website once approved by OSC.

In addition to the pricing and sales terms for the Reseller, the Microsoft Aggregate Agreement 24-02 includes the following documents which have been established between Microsoft and OGS for purchases made pursuant to the Aggregate Agreement:

- Microsoft Business Terms (MBT) - includes certain additional or alternative terms and conditions made in accordance with Section 28 of Appendix B of Contract PM69723 for purposes of the Aggregate Agreement and establishes the overall licensing framework and the applicable terms and conditions for Authorized User use and acquisition of Microsoft Product, which is limited to software and certain Online Services for the Aggregate Agreement.
- Volume Licensing Program Agreements for Enterprise Agreement, Campus and School Agreement, Select Plus Government and Select Plus Academic
- Templates for new enrollments

Authorized Users that enter an Enrollment or place orders using the Microsoft Aggregate Agreement 24-02 will not have to issue a new RFQ or negotiate terms before placing an order (just go direct to Aggregate Reseller, enter into an Enrollment, then place orders). Please note that unless otherwise stated in the documents, the terms for use of the Microsoft Aggregate Agreement 24-02 including the MBT and Program Agreements are non-negotiable between Authorized Users and Microsoft or its Resellers.

Migrate Existing Enrollments to the New Contract:

Authorized Users with existing enrollments under the Microsoft Reseller contract that extend beyond the expiration of the Microsoft Reseller contract, especially those with enrollments that extend beyond three (3) months of expiration of the contract or that anticipate the need to place new orders any time after contract expiration, are advised that they will need to migrate their enrollments to the Microsoft Umbrella Manufacturer Contract PM69723 prior to 7/31/24 to ensure unrestricted and uninterrupted use of their enrollments (i.e. making new orders or payments, updating licenses, receiving necessary patches, etc.).

1. **Migration Requirements:** Migration will require that the terms and conditions to an existing Enrollment under Microsoft Reseller Contract PS68202 and its associated documents be replaced with the terms and conditions of the Umbrella Manufacturer Contract PM69723 and its associated documents. To migrate, an Authorized User must agree to “re-parent” their existing Enrollment and applicable Program Agreement from the Microsoft Reseller contract to the Umbrella Manufacturer Contract via a Migration Amendment to be established between Microsoft and each Authorized User.

To facilitate the process of Migrations, the terms and conditions of the MBT and its volume licensing Program Agreements, as established by Microsoft and OGS for the Microsoft Aggregate Agreement, will also apply for the Migration Amendment. These terms are the same terms that underpin the Microsoft Aggregate Agreement, but orders and pricing for purchases made pursuant to migration agreements will be as outlined in Section 2 and Section 3 below.

It is in an Authorized User’s best interest to migrate enrollments without undue delay and before expiration of the contract to ensure licensing needs will continue to be met and critical services will not be interrupted. Enrollment migration will permit the Authorized User to maintain the existing Enrollment structure and license entitlements including anniversary and expiration dates, make orders and payments without restriction, receive necessary patches, as well as continue to receive pricing as per Section 3 below. Enrollments that are not migrated in a timely manner will be in jeopardy of service interruption and may ultimately require an Authorized User to end existing

enrollments and start new enrollments to ensure service continuity. Be advised that new enrollments do not maintain existing license entitlements and are subject to new pricing immediately.

In addition to the Migration Amendment document to be provided by Microsoft, the following documents apply to existing and migration enrollments (linked and *to be provided by Microsoft):

2. **Reseller for Migrations:** Unless otherwise advised by Microsoft, the originally awarded Reseller from Microsoft Reseller Contract (Dell) will continue to facilitate orders under Umbrella Manufacturer Contract PM69723 for migrated Enrollments through each migrated enrollment's expiration date. RFQs will not be required to migrate or place orders under migrated Enrollments (once enrollment is successfully migrated via Migration Amendment, just go direct to Migration Reseller and place orders).

3. Migration Pricing and Admin Fee:

Migration Pricing

Microsoft commits that, except for Online Services designated in the Product Terms as being exempt from fixed pricing, Microsoft's confidential net pricing to the Reseller for each product ordered under a migrated Enrollment will remain fixed through the migrated Enrollment term(s). In addition, the Category Discounts associated with each Program Agreement in the Microsoft Reseller contract PS68202, Appendix D NYS Price List will continue to apply for Enrollments migrated to contract PM69723 (included here for reference):

OGS Umbrella Administrative Fee

Per Section 2.76 of the Information Technology Umbrella Contract – Manufacturer Based (Statewide) PM69723, a fee equivalent to .75% of the Authorized User price is applicable to all sales under the contract. Because the Microsoft Reseller contract had no fee, and to give additional time for Authorized Users to account for it in future payments, OGS has agreed to waive the Administrative Fee for twelve months following the migration of a given Enrollment. The Reseller for migrations (Dell) is permitted to include the .75% Administrative Fee to all orders including but not limited to Annual Payments, new or True Up orders that take place following the waiver period. For clarity, the waiver will apply for only one annual payment and 12 months of billing for other orders. Prepayment for billing beyond 12 months is not eligible for the waiver.
