\*Produced means to make or manufacture a food item from components or raw materials that were grown upon and/or harvested from the farm or waters through agricultural, horticultural, aquacultural, or dairying processes.

NOTE: Milk on this Award is processed and does not fall under this definition.

\*\*Processed means any alteration of a food item from its raw or original state to enhance its value or render it suitable for consumption. Examples of processing include, but are not limited to, butchering of meat or poultry, cooking, and pasteurizing. Packaging a food item is not considered Processing.

Please be advised that, effective immediately, Authorized Users may begin to experience shortages on orders of half pint (8 oz) and quarter pint (4oz) paper cartons of fluid milk, due to paper carton supply issues occurring nationwide.

Authorized Users may want to consider serving meals with an alternate form of fluid milk, or without fluid milk, due to the temporary supply chain disruption.
