THE FOLLOWING REVISIONS HAVE BEEN MADE TO THE CONTRACT AS PART OF THE RENEWAL AGREEMENT:

MINIMUM/MAXIMUM OBLIGATIONS

American Rock Salt Co., LLC (PC68889)
September 1, 2019 to August 31, 2020

Authorized Users are hereby relieved of their obligation to take 70% minimum (50% minimum for solar salt) of their 2019-20 filed requirements, however, contractor is obligated to deliver up to 150% of the filed requirement for Road Salt and Treated Salt.

For any 2019-20 orders taken from August - December the contractor will defer payments until 1/1/2021.

The contractor has waived all storage fees for the 2019-20 filed requirements.

Apalachee LLC (PC68890)

September 1, 2019 to August 31, 2020

Authorized Users are hereby relieved of their obligation to take 70% minimum (50% minimum for solar salt) of their 2019-20 filed requirements, however, contractor is obligated to deliver up to 150% of the filed requirement for Road Salt and Treated Salt.

The contractor has waived all storage fees for the 2019-20 filed requirements.

Atlantic Salt, Inc (PC68891)

September 1, 2019 to August 31, 2020

Authorized Users are obligated to take 70% minimum (50% minimum for solar salt) of their 2019-20 filed requirements and contractors are obligated to deliver up to 150% of the filed requirements for Road Salt and Treated Salt.

Authorized Users with multiple delivery sites (e.g. NYSDOT, County Highways and NYS Thruway, etc) shall have their minimum/maximum delivery quantities determined based on the sum of all their sites serviced by a Contractor.

When the Authorized User is not able to take the minimum required amount, the Contractor will store salt for the Authorized User at a rate of \$3.50/ton (i.e. Authorized User did not take minimum by 8/31/2020, Contractor will store salt through 12/31/2020).

Storage fee will be waived if Authorized User pre-paid for minimum amount by 6/15/2020.

If storage is necessary for an Authorized User beyond 12/31/2020 the Contractor may offer storage at a per month rate of \$3.50/ton.

Delivery of stored salt between 9/1/2020 and 5/31/2021 shall meet the delivery requirements in the Section titled, *Delivery Schedule*.

Cargill Inc. D/B/A Cargill Inc – Salt, Road Safety (PC68892)

September 1, 2019 to August 31, 2020

Authorized Users are obligated to take 70% minimum (50% minimum for solar salt) of their 2019-20 filed requirements and contractors are obligated to deliver up to 150% of the filed requirement for Road Salt and Treated Salt.

Contractor has extended period to fulfill the 2019-20 filed requirement minimums through 8/31/2021.

Authorized Users with multiple delivery sites (e.g., NYSDOT, County Highways and NYS Thruway) shall have their minimum/maximum delivery quantities determined based on the sum of all their sites serviced by a Contractor.

Where the Authorized User is not able to take the minimum required amount, the Contractor will store salt for the Authorized User and has agreed to waive all associated storage fees.

Delivery of stored salt between 9/1/2020 and 5/31/2021 shall meet the delivery requirements in the Section titled, *Delivery Schedule*.

FUEL PRICE ADJUSTMENTS

For calculating fuel price adjustments, the 2020/21 base rate has been established as posted in the EIA Highway Diesel Prices for New England PADD1A for the week ending July 27, 2020.

Effective September 1, 2020 the new base rate will be \$2.632.

Filed Requirements Determination:

Each authorized user should consider the following before submitting filed requirements for the upcoming contract year:

- Whether they've met their current 70% minimum obligation for the current contract year, and if not, how much additional road salt must be obtained by August 31st in order to meet this obligation.
- The amount of road salt used in the current contract year.
- The amount of road salt not utilized in the current contract year that will be applied to the upcoming contract year.
- In an AVERAGE Winter, the estimated quantity of Road Salt generally used.

Note: Past purchase history and the record of previous filed requirements will assist in making this determination.

Any non-state agency authorized user that fails to submit filed requirements shall be eligible to be added to the delivery schedule at the Contractor's option only. If an authorized user fails to submit filed requirements, but later determines it is necessary, they must follow the procedure to request to be added to the contract in accordance with the contract terms and conditions.
