Please note that the above referenced contract is a Piggyback Contract off MMCAP Infuse Master Contract MMS52200727. MMCAP Infuse updated the following provisions in its Master Contract MMS52200727 via Amendment No. 2 and Amendment No. 3:

1. MMCAP Infuse Master Contract Paragraph 3.6(C) is revised via Amendment No. 2 to MMS2200727 as follows:
 - C. Cancellation and Changes: ~~Members may modify or cancel any pre-booked orders any time prior to shipment.~~ **After the reservation period, Members cannot cancel/reduce their confirmed reservation.** Vendor will send an email confirmation to each Member once their order(s) have been processed and respective prebook doses are available.
2. MMCAP Infuse Master Contract Paragraph 1 of Attachment A, 2023-2024 Pricing and Shipping Commitments is revised via Amendment No. 2 and 3 to MMS2200727 as follows:
 - 1) ~~Reservations may be placed until March 31, 2023~~ **April 14, 2023**. Shipping commitment timelines and percentages of total confirmed influenza vaccine reservation will be based only on confirmed reservations as of ~~March 31, 2023~~ **April 14, 2023**. ~~After March 31, 2023, reservation requests will be accepted subject to product availability~~ the reservation period, Members cannot cancel or reduce their confirmed reservation.
3. MMCAP Infuse Master Contract Paragraph 5(a) of Attachment A, 2023-2024 Pricing and Shipping Commitments is revised via Amendment No. 2 to MMS2200727 as follows:
 - 5) **Returnability:** For direct purchases from Sanofi Pasteur Inc. for the current influenza season, Members may return a limited number of unused and expired doses for credit toward future purchases of influenza vaccines as follows:
 - a. ~~Ten (10)~~ **Fifteen (15)** percent of each presentation of each customer's influenza vaccine shipped during the 2023-2024 influenza season may be returned for full credit.
