Authorized Users and Contractors should note the following regarding the aforementioned contracts:

In accordance with the legislation effective 7/6/22, 19 NYCRR Chapter XIX, Part 905, *Eligible professions for the purchase, sale, and use of body vests* (Statutory authority: Executive Law § 144-a), in New York State all individuals and entities now must present proof of engagement in an Eligible Profession when purchasing or taking possession of body armor.

Authorized Users are advised to review the Department of State website, found through this link: <https://dos.ny.gov/body-armor>, to determine if they meet the criteria and are engaged in an Eligible Profession requiring the use of body armor. There are instructions outlined for the Authorized Users to review and follow including proof of engagement requirements, and further information regarding the legislation and its effects. Contractors are also advised to familiarize themselves with these requirements and follow all required procedures based upon this legislation.

Please be reminded that Award 23227 further defines Authorized Users as entities that meet the definition of an Authorized User in Appendix B, *Definitions* and the definitions of either “Police Officer(s)” as defined by subdivision 34 of §1.20 of the New York State Criminal Procedure Law, or “Peace Officer(s)” as defined in §2.10 of the New York State Criminal Procedure Law
