

How to Use This Contract

The Police Radar/Lidar Speed Enforcement & Speed Advisory Systems, Parts, and Accessories ("Police Radar/Lidar Products") contract(s) is intended to provide a procurement mechanism for State and Non-State Agencies to procure Police Radar/Lidar Speed Enforcement & Speed Advisory Systems, Parts, and Accessories. Additionally, this contract may be utilized by political subdivisions, school districts and others authorized by law, as set forth in Section 6 – *Authorized Users*.

New York State political subdivisions and others authorized by New York State law may participate in Contracts. These include, but are not limited to, local governments, public authorities, public school and fire districts, public and nonprofit libraries, and certain other nonpublic/nonprofit organizations. See Appendix B, §25 *Participation in Centralized Contracts*. For purchase orders issued by the Port Authority of New York and New Jersey (or any other authorized entity that may have Delivery locations adjacent to New York State), the terms of the "Price" clause shall be modified to include Delivery to locations adjacent to New York State.

Upon request, all eligible non-State agencies **must** furnish Contractors with the proper tax exemption certificates and documentation certifying eligibility to use State Contracts. Frequently Asked Questions:

1. What is the Police Radar/Lidar Speed Enforcement & Speed Advisory Systems, Parts, and Accessories Contract?

The Police Radar/Lidar Speed Enforcement & Speed Advisory Systems, Parts, and Accessories contract is a Piggyback contract on the State of Washington's Department of Enterprise Services Master Contract No. 00218 and is intended to provide a procurement mechanism for State and Non-State Agencies to procure Police Radar/Lidar Speed Enforcement & Speed Advisory Systems, Parts, and Accessories. Additionally, this contract may be utilized by political subdivisions, school districts and others authorized by law.

2. What is the Washington Department of Enterprise Services Master Contract?

The State of Washington Department of Enterprise Services is administering a contract to support the current installation of Police Radar, Lidar Speed Enforcement & Speed Advisory Systems, Parts, and Accessories. All items on this contract are in accordance with the National Highway Traffic Safety Administration (NHTSA) Conforming Product List (CPL).

The contract is intended to support the needs of state and local law enforcement for Police Radar, Lidar Speed Enforcement & Speed Advisory Systems, Parts, and Accessories. The contract provides new equipment as well as replacement parts and accessories for existing embedded devices, already owned and in operation by various departments throughout the United States.

3. Can I purchase directly from the Washington Department of Enterprise Services Master Contract?

No. NYS authorized users must purchase from the NYS OGS Contract; Group 38207, Award 23163. OGS contracts contain additional terms and conditions per NYS law.

4. Does the contract include installation services?

No. This is a product only contract whereas products are ordered and shipped directly from the contractors. Installation services, if desired, must be obtained separately.
